An Update on USCIS Filing Fees

USCIS announced last December that they are raising application fees for certain immigration applications beginning **April 1, 2024**.

- **Other notable changes:**
 - There will no longer be a separate biometrics fee (\$85) for most applications.
 - There will be a \$50 discount for filing your application online (for some applications).
 - The total cost for DACA renewals will now be \$555 online or \$605 for paper filing,



Federal Bills



- [American Dream and Promise Act \(HR 16\)](#): The bill remains unchanged from its previous version. See our CIMH website archives for more information on the original bill's protections for DACA, TPS and DED holders and pathways toward citizenship.
- [Asylum Seeker Work Authorization Act \(HR 1325\)](#): The bill would shorten the 180-day waiting period for asylum-based work permits down to 30 days. This bill differs from the Senate version in that it does not require asylum seekers to enter the U.S. through official ports of entry.
- The U.S. Executive Office for Immigration Review and Dept. of Homeland Security issued a directive that all courts should have a children's docket in immigration court. For more information and advocacy efforts, see [Kids in Need of Defense \(KIND\)](#).



What happened with the Senate supplemental funding bill?

A few months ago, a bipartisan group of Senators proposed a national security bill tied to federal aid to Ukraine, Israel, and Taiwan. Read NIJC's full analysis [here](#).



- **Potential pros:**
 - Funding for newly arrived refugees & expanding legal pathways for Afghans.
 - Funding for legal counsel for unaccompanied children.
 - Increases to number of immigrant-based visas & work permits.



- **Cons:**
 - Mandatory border closing based on quotas - 5,000 per day.
 - Expedited screening process and new bars to eligibility for asylum.
 - Increased funding for immigrant detention and deportation.

New Arrivals Update



As of March 8th, Chicago has received an estimated 36,585 new arrivals since the mission began.

- There are 11,593 residents in 23 active shelters run by the city and state.
- Total awaiting placement: 18.
 - 4 waiting at CPD districts, 0 at O'Hare, and 0 at Midway.
 - 14 awaiting placement at the Landing Zone.

- In partnership with the City of Chicago and Cook County Government, Governor Pritzker **announced a \$182 million budget investment** to support the new arrival response. Funding will go to shelter and support services.

Global Updates

- 5 months of **Israel-Hamas conflict** in Gaza has displaced close to 2M Palestinians and killed 31,302 Palestinians and 1,139 Israelis (death toll [here](#)) and led to a rise in anti-Semitic and anti-Muslim hate crimes in the U.S. ([TIME](#); [VOA News](#)).
 - **Action Alerts:** [Amnesty Now](#); [MoveOn](#); and [Jewish Voices for Peace](#)
- 11 months of **war in Sudan** between the Sudanese Armed Forces and the Rapid Support Forces has displaced 8M and killed thousands.
- 2 years of **war in Ukraine** has killed over 30,000, displaced 3.7M, and 6.5M have fled Ukraine.
- Since the **assassination of Haiti's President** in October 2021, gang violence and armed conflict continues to escalate.



Civilians in armed conflict zones are in dire need of humanitarian assistance. They are at extreme risk of famine and disease outbreak due to lack of sanitation, water, and collapsed health care infrastructure.
